

## **2021 KINO BASEBALL LEAGUE**

### **FALL LEAGUE INFORMATION/TEAM REQUIREMENTS**

#### **AGE DIVISIONS 10U TO FRESHMAN**

##### **NARRATIVE**

The following are team entry requirements and policies for teams to review before they decide to enter a team in the 2021 Kino Baseball Fall League program.

The policies and requirements that are outlined are to ensure that the players, coach, and parents fully understand to what the expectations are for competing in the Kino Baseball Fall League.

The Kino Baseball League reserves the right not to accept any team that does not meet these requirements.

##### **FALL LEAGUE DEFINITION**

The Kino Baseball Fall League is a competitive program for age divisions 10U through to Freshman Division. The Kino Fall League is NOT a recreational or developmental type of league. The teams that participate in the league are mainly experienced players and teams. Teams that have not played in a competitive environment may want to re-consider before entering the Kino Fall League.

If you have a team that is looking for development, then possibly the Little League Fall Training and Development (TAD) program may be best suited for your players.

We wish to assure that every young athlete has the opportunity to play at the skill level that they are comfortable with the ability to enjoy playing the game. Nothing is worse than having a team that needs further development playing in a division with teams that have more playing experience in a competitive setting. The results are never positive.

Teams that play in the Kino Baseball Fall League play for championships.

##### **SEASON CALENDAR**

- **10 game regular season**
  - **September 11 to October 17**
- **Post Season Championship Tournaments (format to be determined)**
  - **October 23-31**
- Days of Play:
  - Weekends (Saturday/Sunday) with possible weeknights
- **Black out Dates:**
  - **Only ONE black out (weekend) permitted.** If your team needs more than one black out weekend, then team will not be placed on game schedule.
  - **Black out dates required to be sent via email by AUGUST 25, 2021.**
- Schedule to be published September 1, 2021.

## GAME SCHEDULE POLICY

- The number of games: 10 + Post-season tournament. Format to be determined.
- Days of play: Saturdays, Sundays. Weeknights (possible)
- Game Times: Day games. Weeknight games (possible)
- The league understands that in the fall there are school breaks, and some teams may have committed to play in a tournament., but it must be clear and understood that playing in the Kino Baseball Fall League is a priority. Therefore, the following policy:
  - **Teams will be permitted ONE (1) black out weekend. Multiple black out weekends are an inconvenience and effects other teams and the overall operation of the league as a whole. Therefore, request for multiple black out weekends the team will be not be entered into the fall league.**
  - **Black out dates are required to be submitted to the league by AUGUST 25.** After this date, the game scheduled will be developed and published to teams by September 1.
  - The league cannot accommodate special game times to play. **EXCEPTION:** The league understands that during the fall season there are players that play in the local youth football leagues. The league in the past and will once again work with those teams that have such a situation. But it must be understood that these teams are held to the same standard with only ONE black out weekend permitted.
- **The league does not schedule around UA football games, Little League Fall Games, or any other events.**
- **Once the schedule is official requests to move game times will not be honored. Teams play on the game time as scheduled unless there are circumstances that the league needs to adjust based on field availability, emergencies, etc.**
- It is important that the coaches meet with parents to determine any dates the team cannot play before they commit to the league.
- Due to the limited number of fields the league has permitted from the city and county for the fall league, once the game schedule is developed and published it becomes FINAL.
- If a team has a “situation” and needs to re-schedule a game, the league will evaluate the “situation” and determine to either approve or not approve the re-scheduling. If fields are available, the process is the requesting coach will contact the opposing team coach to get their approval. If the opposing team cannot make any of the dates available, then the team requesting the schedule change will forfeit the game.
- **RE-SCHEDULE GAME \$50.00 and must be paid in full to the league prior to the request being approved. Payment can be made with credit card by contacting the league.**
- **POST-SEASON:**
  - There are no black-out dates permitted during the dates of the post-season play. Teams need to be available to play both Saturday and Sundays for the post-season. There are no accommodations for game days or game times during the post-season.
  - The format for the post-season tournament is to be determined by the league pending the number of teams that have been certified to play. Understand that the tournament format may not include every team in the division.
- **If a team contacts the league 72 hours or less prior to a scheduled game to cancel, the game will be a forfeit and not re-scheduled and the team will be responsible for payment of \$150.00 to the league.**

## GAME SITES

- Games will be scheduled to be played at various other city, county, and school fields throughout Tucson.
- Fields are prepared prior to each game by the league field crew staff. The staff will line the field, put out the bases, and at the conclusion of each game, the field staff will collect and put away the bases. Teams will not have to do field duty. This is a cost that is included in the team's entry fee.
- Teams are required after each game to collect and throw away all debris and trash generated during the game. The league does not clean up dugouts. If a dugout is not cleaned out, the league will fine the team \$50.00.
- Spectators are expected to clean up and remove debris and trash in their seating area before they leave the park.

### STEP 1 – TEAM INTEREST:

Coach is to email the league at [kinobbbl@comcast.net](mailto:kinobbbl@comcast.net) noting interest in what division they wish to play in. This does not guarantee a spot in the league until the following steps are accomplished:

### STEP 2 – DEPOSIT

- **AUGUST 1 Entry Fee deposit of \$250.00 begins and must be received on/or before August 25, 2021. The deposit will secure spot in the fall league.**
- Deposit can be in the form of a check or debit/credit card.
- Check is payable and mailed to:
  - Kino Baseball League - PO Box 89304, Tucson, Arizona 85752
- Debit/credit cards are accepted over the phone by calling 520-730-2506 between the hours of 10:00 AM to 5:00 PM seven days a week. Credit card payments subject to 5% fee added to payment.
- Entry fee balance due to be paid in full on September 8-9 (See meeting schedule at the end of this information form)

- 12U Wood Bat Division: \$ 1,250.00
- 13U Division \$ 1,350.00
- Freshman (13-15 Division) \$ 1,500.00
- **CREDIT CARD PAYMENTS ADD 5%**

### The entry fee covers the cost of:

- Umpires, Fields, Field Equipment (bases, chalk), 2 dozen game baseballs, post-season baseballs, and awards.
- Entry Fee can be paid in full by cashier check, money order, one personal check, or by debit/credit card by phone.

### CREDIT PAYMENT PROCESS:

  - Monday through Saturday 10:00 AM to 5:00 PM
  - Closed Sunday

## REFUND POLICY:

- 100% refund (less cost of baseballs) if team requests on/or before September 1<sup>st</sup>.
- Zero refund after September 1<sup>st</sup>.
- **All refunds credited back to a credit card are subject to 5% fee that is charged by credit card companies as part of the transaction.**

## DIVISIONS

The Kino Baseball 2020 Fall League will consist of the following divisions:

- 10U Division
- 11U Division
- 12U Wood Bat Division
- 13U/80 Division
- Freshman Division (league eligible ages 13 through 15)

There must a minimum of four (4) teams to sanction and schedule a league.

## PLAYER ELIGIBILITY

### • **AGE CUTOFF: MAY 1, 2022**

**The league cutoff is alignment with NCS and USSSA**

### • **PLAYER PROOF OF BIRTH:**

- Coaches are required to maintain copies of each roster player on them at the park for every game.

### • **WAIVER:**

- Players that play in the league, parent/legal guardian is to complete Waiver form that is identified APPENDIX B at the end of the information document.
- **The waiver of each player is to be emailed to the league by the following date:**
  - September 8-9
  - No waiver submitted the player is not eligible to play until one is received by the league.
  - Waiver to be emailed ([kinobbl@comcast.net](mailto:kinobbl@comcast.net)). **DO NOT TEXT WAIVERS**

## TEAM COMPOSITION

- MINIMUM number of registered players on a team roster is 10.
- MAXIMUM number of registered players on a team roster is 20.
- The team roster form (APPENDIX "C") is at the end of this document.
- The roster form is to be signed by each parent or legal guardian verifying the player name and date of birth.
- Coach is required to **submit the team roster at team certification night:**
  - 10U-11U-12U Divisions: On/or before SEPTEMBER 8, 2021
  - 13U and Freshman Divisions: On or before SEPTEMBER 9, 2021
  - Roster is closed effective SEPTEMBER 24, 2021. No further players may be added to the roster.
- Coaches are responsible for either email or text notification to the league when adding a player.
- When entry fee deposit is received by the league, a team roster form will be emailed to the coach that is required to be completed and signed by each parent verifying the player date of birth.
- **Player is NOT PERMITTED to play on another team within the same age division.**
- Player that meets the age eligibility requirements IS permitted to play on a team in a separate age division.
- Player that leaves the team for any reason at any time after the season has started is not permitted nor eligible to play on any other team within the same division for remainder of the season.
- Player trades between teams are NOT PERMITTED.

## PARENT/COACH/PLAYING TIME

- There is no mandatory play in Kino Baseball League
- The league does not get involved with team business such as player selection, player removal, discipline, finances, playing time, etc. These issues are between the parents and the coaches.
- The league Child Abuse/Molestation Management Policy and Plan is monitored by the league in the event of a complaint received by the league. The policy is posted on the league web site [www.kinobaseball.com](http://www.kinobaseball.com) browse "Policies."



# Banner University Medicine Orthopedics & Sports Medicine

Banner University Medicine is the official sports medicine partner of the Kino Baseball League. Banner University Medicine and the Kino Baseball League **is offering this option** to families that participate in the any Kino Baseball League season a benefit of having the opportunity to have direct and expedited access to the Banner Health System.

In the event of an injury, Banner University Medicine can quickly assist your athlete scheduled for an evaluation, MRI, X-Ray, or any other healthcare need. There is no obligation to participate and there no fee associate with pre-registration process.

To assist Banner University Medicine in the expedition of your athlete's care, it is recommended that your player pre-register in the Banner system to avoid delays in scheduling. If you would like to be pre-registered in the Banner Health System (good for any Banner Hospital in Tucson, Phoenix and Colorado, please complete the form that is listed as **APPENDIX A** and email to the league.

The league will forward the pre-registration form onto Banner University Medicine. Again, this is **optional benefit**.

## **DIVISION AGE LIMITATIONS**

### • **10U DIVISION**

- Minimum age is 8 years old.
- Player is required to turn age 8 prior to May 1, 2022.
- 7 years of age and younger are not eligible for the 10U division.
- Player that turns age 11 prior to May 1, 2022 is not eligible for the 10U Division

### • **11U DIVISION:**

- Minimum age is 9 years old.
- Player is required to turn age 9 prior to May 1, 2022.
- 8 years of age and younger are not eligible for the 11U Division.
- Player that turns age 12 prior to May 1, 2022 is not eligible for the 11U Division.

### • **12U WOOD BAT DIVISION:**

- Minimum age is 10 years old.
- Player is required to turn age 10 prior to May 1, 2022.
- 9 years of age and younger are not eligible for the 12U Division.
- Player that turns age 13 prior to May 1, 2022 is not eligible for the 12U Division.

### • **13U DIVISION:**

- Minimum age is 11 years old.
- Player is required to turn age 11 prior to May 1, 2022.
- 10 years of age and younger are not eligible for the 13U Division
- Player that turns age 14 prior to May 1, 2022 is not eligible for the 13U Division.

### • **FRESHMAN DIVISION (Ages 13 through 15)**

- Minimum age is 13 years of age. Maximum age is 15 years of age.
- Player is required to turn age 13 prior to May 1, 2022.
- 12 years of age and younger are not eligible for the Freshman Division.
- Player that turns age 16 prior to May 1, 2022 is not eligible for the Freshman Division.

## COACH CERTIFICATION REQUIREMENTS

It is required that all first year managers and assistant coaches that participate in a Kino Baseball League sanctioned season must have one of the following coaching certifications.

1. Valid Arizona teaching certificate, Arizona coaches certificate or has completed each of the following criteria from the National Federation High Schools (NFHS) on line ([www.nfhs.org](http://www.nfhs.org)) Level 1 Certification to include:
  - a. Fundamentals of Coaching
  - b. 1<sup>st</sup> aid safety and current CPR certification

**OR**

2. Certification of having completed the following USA BASEBALL online ([www.usabaseball.com](http://www.usabaseball.com)) **FREE** course.
  - a. Abuse Awareness for Adults
3. The league requires that the team manager and at minimum three (3) assistant coaches have one of these certifications:
  - a. Returning coaches that participated in 2017-18-19-20 their certification is on file with the league.
4. These on-line courses in requirement 2 are **FREE**. Courses in requirement #1 there is charge that the coach pays directly to the NFHS. This requirement is for only those new coaches to the league that did not coach in the fall league in 2017-18-19.
5. **Copies of certifications are to be scanned in pdf format (no text pictures) and emailed to the league at [kinobbl@comcast.net](mailto:kinobbl@comcast.net)**
6. **DEADLINE FOR SUBMISSION of certificates by email ([kinobbl@comcast.net](mailto:kinobbl@comcast.net)) due on/or before September 9, 2021**
7. Certificates to be emailed ([kinobbl@comcast.net](mailto:kinobbl@comcast.net)) in pdf format.
8. **PENALTY:** Coach not meeting this standard will not be permitted to be in the dugout or on the field of play during a league game until the certification standard has been met.

## INSURANCE

- Teams that participate must provide the league with a Commercial General Liability certificate of insurance that names Kino Baseball League as additional insured.
- Resources for sports insurance includes:

  - Sadler Sports and Recreation ([www.sadlersports.com](http://www.sadlersports.com)) 800-622-7370
- Liability Insurance with limits of not less than:
  - Each Occurrence \$2,000,000
  - General Aggregate \$2,000,000
- **Team is to email to the league the certificate of insurance on/or before SEPTEMBER 9, 2021.** Team will not be certified nor permitted to play without the submission of the insurance certificate.
- The league has liability insurance that covers all participating teams, the city, county, and school fields that games are played on.
- There is NO medical/accident insurance provided by the league for the fall season. If a player or coach gets injured during a practice or game, or in vehicular accident while go to or from practice or a game and requires medical treatment they do so on their own health care insurance and medical providers.

## UNIFORMS

- Players required to be in full baseball uniform that is defined as pants, cap and matching colored jersey with a number on the back.
- Duplicate numbers permitted, but the coach on the line-up card must list letter “A” and “B” next to the corresponding duplicated numbers.
- Player must have a number on the back of the jersey. Player that has no uniform number, they are not eligible to play in the game.
- Coaches are to dress professionally and must wear a baseball cap, visor or sun hat when in the coach box.

## LEAGUE RULES

- The fall league rules will be emailed to all team managers to review with coaching staff, players and parents.
- The rules will be posted on the league website [www.kinobaseball.com](http://www.kinobaseball.com)



## **BAT SPECIFICATION**

### **(Effective 2021 Fall Season)**

- **10U & 11U DIVISIONS:**

- No longer than 32 inches
- Barrel diameter may not be larger than 2 5/8"
- Bat must be USABat certified stamp.

- **12U WOOD BAT DIVISION:**

- No longer than 32 inches
- Solid one- piece wood only (ash, maple, birch) OR
- Composite wood is permitted

- **13U DIVISION:**

- No longer than 34 inches
- Wood or metal is permitted
- Barrel diameter may not be larger than 2 5/8"
- **Metal bats must be BBCOR, USABat OR USSSA 1.15 BPF stamped.**
- **Bat drop -8 or heavier permitted.**



- **FRESHMAN DIVISION:**

- No longer than 34 inches
- Barrel diameter may not be larger than 2 5/8"
- Bat must be BBCOR certified stamp or player can use solid one- piece wood bat



## **FORFEIT POLICY**

- Teams may start with eight (8) players.
- Team that does not have minimum eight (8) players at game time will forfeit to the opposing team. There is no “grace time period” granted.
- Forfeit fine: **\$150.00** payable to the league prior to the team’s next scheduled game.
- When a game is forfeited the umpires will leave the field. The umpires will not stay and do “scrimmage” games between teams.
- Team that has a player get injured or is ejected and the team is left with 8 players and there are no eligible substitutes available, the game is forfeited at that point. There is no forfeit fine assessed.
- Team that requests to re-schedule a game, they will be required to pay the league \$50.00 fee (credit card). The league will review any open fields and dates and will advise the requesting coach. The requesting coach will contact the opposing team coach and ask about a re-schedule. If the opposing team coach agrees, then the game will be re-scheduled. If the opposing team coach does not wish to change the game date, then the requesting team forfeits that game.

# CONDUCT

Adult coaches set the example for their team when it comes to how they conduct themselves during a game. Debating or questioning calls with the umpires is part of the game, but it is how one conducts themselves during their interaction with the umpires that determines if a coach remains in the game without being ejected.

Using profane language, doing damage to equipment, kicking dirt, physical contact with an umpire, non-stop talking to the umpires regarding balls/strikes, judgment related calls, unsportsmanlike conduct of any kind are causes for an individual getting ejected from a game.

The policy of Kino Baseball League regarding conduct is as follows:

- Umpires never lose a game for a team. Umpires do not care who wins or loses a game. They make calls and rulings as they in their judgment see them. They are the final say in a game.
- Umpires can restrict an individual to the bench for the remainder of the game. The restricted individual is not permitted to participate in any aspect of the game. If the restricted individual continues to argue with the umpires in any form, then the individual is ejected from the game.
- Manager or coach that is ejected from a game, they must immediately leave the field and go directly to the parking lot. "Out of sight, out of mind." Failure for the ejected individual to leave the playing field immediately will result in further disciplinary action determined by the league.
- Player that is ejected from a game is restricted to the bench for the remainder of the game. If the parent(s) of the ejected player are in attendance, they may take their player and leave the park. The ejected player is not permitted to sit outside the playing field with their parents or with the spectators.
- **SUSPENSIONS:** The league will review the ejection report submitted by the umpire to determine if further disciplinary action in the form of a suspension is required.
  - Individual that gets ejected more than once during a season will receive an automatic minimum one (1) game suspension. Further game suspension will be determined by the league based on the umpire report.
  - Manager or coach that is suspended is not permitted to be at the park for the team's next scheduled game. Stay home.
  - Player that is suspended is required to be in attendance at the team's next scheduled game and sit on the bench with his teammates. If the player does not attend the game, the suspension carries over to the next game and so forth until the suspension requirement has been met.
- Umpires have the authority to eject individuals after the game is over, that will require the ejected individual to not attend the team's next game.
- Ejected individuals are not to waste their time calling or emailing the league to complain about an ejection. Umpires are in charge of the game and they have full authority to control the individuals that are participating, and if in their **JUDGMENT** and individual's conduct is not within the rules of sportsmanship and behavior in front of young athletes, they will get ejected from a game. No appeal, no discussions.
- Any physical altercations with any individual or team whether it be on the field or in the parking lot will result in the individual(s) involved to be terminated from the league for the remainder of the season.
- Any individual that displays threatening gestures or verbally threatens another coach, player, umpire, league official is terminated from the league for the remainder of the season
- The league will communicate with the ejected individual via email regarding any suspensions. Failure for an individual to check their e-mail is not a reason for not knowing about the league action of suspension.

## SPECTATOR CONDUCT

The permits and contracts for fields from the city, county and school districts require the league to be responsible for the safety and security of the players, coaches and spectators that attend games.

Coaches are responsible for controlling their spectators. If the umpires request coach's intervention with any spectator, it is fully expected that the coaches will assist. Failure for a coach to assist, the umpire has full authority to eject the coach from the game.

Spectators can be ejected from the park. Failure for ejected spectator(s) to leave the park, the game will be suspended by the umpires until the ejected spectator(s) have left the park. If the ejected spectator(s) fail to leave, the law enforcement will be contacted to have the individual(s) removed from the park.

Spectator(s) can be banned from a public park if their conduct becomes a detriment to the safety and security of the players, coaches, umpires, and those spectators around them.

**PARTICIPATION WAIVER**

1. As participant in the Kino Baseball League I acknowledge, agree and represent that I voluntarily choose to participate in the league, baseball related activities, and other activities incidental to the league organized by the Kino Baseball League.
2. I understand that there are risks and hazards involved in participating in the league and related activities that may result in injury and/or death to me or to other participants.
3. I understand that these risks and hazards include, but are not limited to, risks and hazards associated with playing conditions, equipment, other participants, and officials and risks and hazards caused by the negligence of the participants and others, including the organizers, persons assisting them, and the facilities owner.
4. I understand that the very nature of the game of baseball is hazardous and risky, including, but not limited to, the acts of throwing, hitting, and catching the ball, running, jumping, stretching, sliding and collisions with other players and with stationary objects all of which acts can cause serious injury to me and to other players and officials.
5. I understand that there may be risks and dangers that are not known to me or that are not reasonably foreseeable at this time.
6. I accept and acknowledge the increased risk of contracting COVID19 while participating around the league and it facilities which the league rents for sports events.
7. I assume all risks and liability and HEREBY RELEASE, INDEMNIFY, AND HOLD HARMLESS the Kino Baseball League, OTHER PARTICIPANTS, and any FACILITIES where the game are played.
8.
