The following are established policies for facility use of the Kino Sports Complex South Fields and Kino Veterans Memorial Stadium as contracted with the Kino Baseball League

Each team that participates in the Kino Baseball League is responsible for communicating these policies to their players and supporters of the team.

Complex Address		2500 East Ajo Way
PARKING	Free	For the South Fields parking is located on the south side of the stadium in the lots where covered parking is located
ENTRANCE		The gate and entrance to the fields will be direct left of the Administration Building

Gates will open 60 minutes prior to the first games of the day

FOOD AND BEVERAGE POLICY

- 1 Kino Sports Complex will conduct bag checks and has a strict policy on outside food and beverage.
- 2 **CONCESSIONS** will be available.
- DUGOUTS: Water coolers with ice, water and cups will be provided to each dugout for player and coach use.

 TEAM COOLERS NOT PERMITTED.
- 4 NO OUTIDE FOOD, BEVERAGE OR COOLERS ARE PERMITTED INSIDE THE KINO STADIUM OR THE SOUTH FIELDS.

Fans either leave these items in their vehicles or dispose of them at the security check point at the stadium or to the South Fields.

The ONLY exceptions are:

- A) Each person is permitted to bring in one (1) sealed water or sports drink.
- B) Food and beverage items for infants two years of age or younger is permitted.
- C) Player in baseball uniform can bring in multiple bottles of water, sports drinks.
- 5 **BAG CHECKS**: County event staff have the authority to conduct bag checks
- 6 ALCOHOLIC BEVERAGES ARE STRICTLY PROHIBITED INSIDE THE STADIUM AND THE SOUTH FIELDS
- 7 **BOTTLES/CANS:** Fans are not permitted to bring in any type of bottles, cans, thermos or beverage containers inside the stadium and the south fields. Exception is that individual can bring in one (1) sealed bottle of water or sports drink.

- **TOBACCO** products including cigaretter, cigars, pipes, smokeless tobacco, water pipes, hookah, e-cigarettes, chewing tobacco, snuff and other products containing tobacco are PROHIBITED.
 - Smoking is prohibited at all times on county facilities, public buildings and adjacent properties.
- Bikes, scooter, roller blades/skates, hover boards, skateboards and any other items that is deemed unsafe around the public is strictly PROHIBITED. If an individual comes to the security check point with any of these itmes they will not be granted access to the facility.
- STROLLERS are permitted. However, their use should not in any inhibit fan movement or black any aisles in the staidum. Smaller, umbrella style strollers can be stored underneath a seat as long as they do not creat an obstruction for other fans.
- ANIMALS: Service animals permitted. Security event staff have the authority to ask the individual with the service animal to provide certification of such an animal. If no certification can be produced, the security event staff can refuse the individual admission.
 - ALL OTHER NON-CERTIFIED PETS ARE NOT PERMITTED.
- WAGONS: Are permitted to be brought into the south fields to carry lawn chairs, umbrellas, pop up tents (NO COOLERS) but are subject to inspection by the security event staff.

 Wagons are not permitted inside the stadium.
- 13 UMBRELLAS/LAWN CHAIRS

Not permitted inside the stadium Are permitted at the south fields.

14 POP UP TENTS

Not permitted inside the stadium Permitted at the south fields but are not permitted to be staked into the ground.

WEAPONS: Firearms or any other weapons are not permitted inside the stadium or the south fields. In accordance with Arizona House Bill 2457, law enforcement officials attending an event are permitted to bring firearms inside the stadium or at the south fields if they are in compliance with the Arizona peace officer standards and training board requirements.

- LOST AND FOUND: If during your visit to the staidum or the south fields and you misplace an item or find something that belongs to another fan, please bring to the concession stand. Fans inquirings about lost items are to contact 730-2506. The Kino Baseball League and the Pima County Stadium District cannot be held responsible for lost or damaged items.
- PARKING: The Kino Baseball League, its sponsors, organizers, Pima County Stadium District and Pima County do not assume any liability for the theft, damage to vehicles or personal property or for any injury arising from foul balls, broken bats or any occurrence in or around the stadium or south fields.
 - For your vehicle security purposes do not leave personal items (pocketbooks, wallets, money, lap tops, credit cards, etc) in your vehilce.
- EJECTION: Fans that refuse to the follow the direction of the county security event staff or officials of the Kino Baseball League will be subject to ejection without a refund. The league officials and event staff have the full authority to call local law enforcements to enforce in the removal of an individual from the stadium or south fields. Any individual ejected from the facility is banned from returning for the remainder of the season.
- 19 RESTROOMS with baby changing stations are available at the stadium and the south fields.
- 20 COVERED BLEACHER SEATING is available at the south fields.

THE COUNTY EVENT STAFF HAS FULL AUTHORITY TO REFUSE AN INDIVIDUAL ENTRANCE TO THE STADIUM OR SOUTH FIELDS FOR VIOLATION OF ANY POLICY OR CONDUCT THAT BECOMES BELIGERENT AND A SAFETY CONCERN TO THE PUBLIC AND PARTICIPATING TEAMS.

ADMISSION

- Admission will be charged at the security entrance gate at the stadium and to the south fields. The admission is operated by the Kino Baseball League.
- 2 Established admission rates will be advertised on the league website and will be communicated with the team managers prior to the start of the season. and will be posted at the main security gate entrance.
- Admission payment is in the form of cash. No personal checks or credit/debity cards are accepted.
- Paying customer will receive a ticket that will allow them re-entry access during an event. Failure to show the league admission staff the ticket upon re-entry, the individual will not be permitted back into the stadium or south fields and will be required to purchase a new ticket.

REFUND

In the event games get rained and have not reached regulation (4 1/2-5 full innings) the paying customer can either hold onto the ticket and use as a "rain check for admission to a future game, or they can receive a refund back..

Once a game becomes official and the game gets rained out, no refunds or rain checks will be honored.
